- 17. Selection for appointment to the JE (Ordinary Grade) Promotion :-
- (1) For purpose of recruitment to the posts in the Ordinary Grade under regulation 5 (b) (ii) a selection based on merit shall made from the following:-
- (A) 40% from the members of operating staff-(skilled) from the category of T.G.I/T.G.II (P4, P5 and P6) in U.P. Rajya Vidyut Parishad Parichalkiya Karamchari Varg Sewa Viniyamavali, 1995 (as amended) according to the following criterion on interview basis

Total number of marks allotted will be 100 which will be distributed as under :-

- (i) High School
- 10 Marks
- (ii) Intermediate
- 10 Marks
- (iii) Higher than Inter
- (iv) I.T.I.
- 25 Marks
- Or/if Diploma or 35 Marks
- higher (v) Experience
- 25 Marks
- (one mark for each year of service
- as T.G.-I/T.G.-II)
 - 10 Marks

17. Selection for appointment to the post of JE (E&M) by promotion :-

For purpose of recruitment to the post of Junior Engineer (E&M) under clause 5(b)(ii) of this regulation, a selection based on objective test shall be made from the following:-

- 40% from T.G.II (P4) in U.P. Rajya Vidyut Parishad Parichalkiya Karamchari Varg Sewa Viniyamavali, 1995 (as amended) by way of filtration as described in clause 17(C), 17(D) and 17(E) of this regulation.
- 8.33% horizontal reservation shall be provided to those T.G.-II (P4), who have attained higher technical qualification; such as, Degree / Diploma.

Such candidates will also be selected by way of filtration as described in clause 17(C), 17(D) and 17(E) of this regulation.

However, the following condition shall apply:-

(1) That the candidates having obtained Degree/Diploma by way of distance learning education program or off campus program shall not be eligible under this 8.33% category.

That the candidates having obtained Degree/Diploma from the institutions not

Provided :-

- (a) There is no punishment/misc. advance awarded or disciplinary preceding pending and there is no adverse reporting in the available Annual Confidential reports for the past 10 years immediately preceding the selection.
- (b) Minimum qualifying marks shall be 40 out of
- (c) The selection and interview for these candidate shall be carried out through a committee as defined below:-
 - (i) Chief Engineer.
 - (ii) One Superintending Engineer to be nominated by Chief Engineer.
 - (iii) Deputy Secretary/Executive Engineer (P&A)

The intense seniority of candidates selected shall be arranged in accordance to the merit in the list prepared by the above mentioned procedure.

- (B) 8.33% horizontal reservation shall be provided to the Members of Operation Staff who have higher technical qualification such as Diploma or Degree and have completed 2 years service after the completion of the aforesaid Diploma/Degree before commencement of the selection year.
- (i) The selection shall be based on a objective test followed by a interview to which only such candidates would be admitted as have qualified in the written test.
- (ii) The names of the candidates who qualify in the interview shall be placed in a list in their order of merit. For computing the merit of a candidate the marks obtained by him both in the written test and interview shall be added.
- (iii) The number of names in the list drawn up under clause (ii) shall not exceed the number of vacancies announced at the time of the announcement of the examination by more than 25%.
- (iv) The syllabus and marks for the written test, interview shall be laid down by the Chief Engineer (O&M).
- (v) A Committee comprising (as specified above in A{c}) will supervise the written examination and hold interview test.
- (vi) The Chief Engineer shall have the power to remove the name of any candidate from the

recognized by the government shall also not be eligible under this 8.33% category.

(C) Qualifying Examination & Process of Filtration:-

- 1. A candidate will have to appear in an objective test in the following subjects:-
- (a) Technical Knowledge 100 marks
- (b) Computer Knowledge 50 marks
- (c) General Hindi 25 marks
- (d) General Knowledge 25 marks & Reasoning

Total marks - 200 marks

- 2. The objective test will be of 2 hrs. 30 minutes duration, having four options in each question with no negative marking.
- 3. The objective test in Technical Knowledge and in Computer Knowledge will consist of 50 questions and 25 questions respectively having a weightage of two marks for each question.

Similarly, the objective test in General Hindi and in General Knowledge & Reasoning will consist of 25 questions in each having a weightage of one mark for each question.

- 4. Apart from other provisions of selection procedure, a candidate must have to secure a minimum of 67 marks out of which at least 34 marks must be obtained in Technical Knowledge.
- 5. It will be mandatory for all the prospective candidates to qualify this filtration test, irrespective of the fact, whether a T.G. II is having a diploma or degree in a technical field. Failing to which the candidature will be treated as disqualified for selection.

(D) Eligibility for appearing in qualifying test:-

- 1. A candidate must be confirmed on the post of TG-II (P4).
- 2. A candidate having qualification other than Degree/Diploma must have to complete a continuous service of 10 years on the post of TG-II (P4).
- 3. A candidate having a Degree/Diploma will be considered under 8.33 % horizontal reservation after having completed a

list drawn up under Clause B(ii) if his work or conduct at any time subsequent to the holding of the tests is reported to be such as to render him unfit for promotion.

continuous service of 5 years on the post of TG-II (P4).

(E) Other terms & conditions

Final selection will be subject to fulfillment of the following conditions:-

- 1. The Annual Confidential Reports immediately preceding 10 years or 5 years to the relevant selection year, as the case may be, shall be considered. Out of which 60% of ACRs must be satisfactory with the condition that there should not be any adverse entry in the ACR immediately preceding to the selection year.
- 2. No pending enquiry at the time of selection. Otherwise, selection will be put under sealed cover.

(F) Seniority:-

1

- 1. A combined seniority list of TG-II shall be prepared at HQ level. Consequent upon promotion to the post of Junior Engineer, their seniority shall remain unaltered.
- 2. Marks obtained in qualifying test shall not affect the seniority after promotion to the post of Junior Engineer.
